Notes on Admission and Candidate Questions

1. NOMINATION OF CANDIDATES:

- a. Both the Proposer and the Secunder must have been Full Financial Members for a minimum period of 5 years.
- b. The Proposer and the Secunder may be members of the same family where 'family member' refers to parent, child, sibling, aunt, uncle, grandparent.
- c. The Candidate is older than 18 years.
- d. The Candidate is well-known to the Proposer and Secunder for a minimum period of 3 years.
- e. The Proposer and Secunder have provided the Candidate with the Clubs Constitution, Debenture Conditions, Waiting List Process, Operations Manual and other relevant Club documentation (i.e. Covid Safe Plan).
- f. Prospective Member Waiting List Candidates must have stayed at the Illabunda Lodge during winter (in the year of their application) as part of the application process.
- g. Prospective Member Waiting List Candidates may be removed from the list if they "...have not contributed to the club (lodge stay, working bee, raced/coached, etc...)". The waiting list is reviewed annually.
- h. It is the duty of the Proposer to organise collection of signatures and other details before lodging the application form.
- i. The Proposer and Secunder must be certain that the Candidate has all the necessary qualifications for membership. Considerations of expediency, business, political, religious or personal obligations must play no part, but rather the test "Is this Candidate the type of person who I would gladly and regularly welcome into my home?" should be applied.
- j. The Proposer and Secunder must complete the "New Member References" section of this form, supporting their nomination for the proposed new Members.

2. CANDIDATES WHO FAIL TO BE ADMITTED TO THE WAITLIST:

It is inevitable that some candidates will not be admitted to the member waiting list. In such cases, the Committee will notify the Proposer. The Committee will endeavour, in all cases, to act in the best interests of the Club. If an applicant has failed to be admitted, no reasons for refusal will be given.
